The year 2024 stands as a significant milestone for the International Organisation of Vine and Wine (OIV), as it celebrates its centenary since its foundation. In this framework, the OIV proudly launches the “2024 CENTENARY PHOTO CONTEST – PAU ROCA”, dedicated to honouring the legacy of Mr. Pau Roca, the former Director General who served from 2019 to 2023. Mr. Roca, who recently passed away, dedicated his tenure to addressing one of the foremost challenges confronting the vine and wine sector: Climate change.

In recognition of his invaluable contribution to the OIV and the vine and wine sector, as well as in remembrance of his remarkable leadership, the OIV under the sponsorship of Vinos de la Luz, is proud to launch this photo contest under the theme “The vine and wine sector facing climate change”.

Join us in capturing the essence of this challenge through your lens!

The call for entries will be open from 4 April to 10 September 2024, 18h (CET TIME).

About the OIV

The OIV was created in 1924 by eight Member States as a response to the international viticulture crisis. The OIV is a technical and scientific intergovernmental organisation which operates under a renewed agreement, signed in 2001. It serves, today, as the Organisation which brings together the world of vine and wine to collaborate within the sector. The OIV aims to inform, assist, harmonise, standardise, and support the vitivincultural sector. To achieve these goals, the OIV works through a network of over 1,000 experts from around the world. All final decisions of the OIV are taken by consensus of the 50 Member States of the OIV. This work is for not only Member States but also other international organisations and the vitivincultural sector as a whole.

1. Introduction

The OIV centenary photo contest aims to invite photographers of all backgrounds and all levels to participate. Through this activity, the OIV aims to celebrate its centenary from an artistic point of view.

2. Applicants

The contest is open to photographers of all backgrounds and all levels over 18 years old, from all over the world.

3. Documentation to be submitted

Participants are required to apply through an online form available on www.oiv.int. The form must be completed with personal information such as name, address, place of residence, etc., in English.

Each participant must submit three (3) unpublished photos via a platform such as WeTransfer or Dropbox, providing a download link that must be included in the online form.

All photographic images must be in JPEG format and RGB colour mode. JPEGs should be at least 6.3 Megapixels (3000 x 2100 pixels) in size and have a resolution of 300 dpi.

Photos could be in both horizontal and vertical format.

Black and white / colour photographs will be accepted.

Photos must be clearly captioned, including a title, a location and the date of the photograph.

Images that have been altered by collage, photomontage or digital illustration will not be accepted. Photos created or edited with artificial intelligence will not be accepted. Only photo retouching is allowed without altering the original content of the photograph.

4. Registration

All applications will only be received via the online application form. Submission by mail or e-mail will not be accepted.

The deadline for submissions of entries is 10 September 2024, 18h (CET TIME). No applications will be accepted after this date/time.

The application shall be considered as a sworn statement on the authorship of the projects submitted by the participant and shall be an authorisation for an indefinite period of time for the OIV to use, exhibit, disseminate, publish in different media and/or reproduce the photos in whole or in part (with the corresponding copyright), in the event that it is awarded a prize. Projects will not be used for any purpose other than that of the OIV, nor will any profit be made from the works.

By registering and submitting the application, each participant agrees to hold the OIV exempt from any claim, judicial or extrajudicial, received from third parties in relation to authorship or intellectual property rights.

If you choose to include individuals in your photograph, you are responsible for obtaining the necessary consent from the portrayed individuals and must be able to provide copies of such consent upon request.

The members of the OIV staff are not allowed to participate, nor their immediate family (spouse, mother, father, sons, daughters) or those who are part of their household. OIV experts are allowed to participate.

5. Jury

The evaluation of photographs will be conducted by a jury of the vine and wine field, designated for this purpose. They will be chosen at the discretion of the OIV representatives.

Decisions will be adopted by simple majority.

6. Prizes

First prize

- €2500
- Display of the winning photograph in the OIV new headquarters, Hôtel Bouchu d'Esterno, in Dijon, France

Second prize

- €1500
- Display of the winning photograph in the OIV new headquarters, Hôtel Bouchu d'Esterno, in Dijon, France

Third prize

- €1000
- Display of the winning photograph in the OIV new headquarters, Hôtel Bouchu d'Esterno, in Dijon, France
